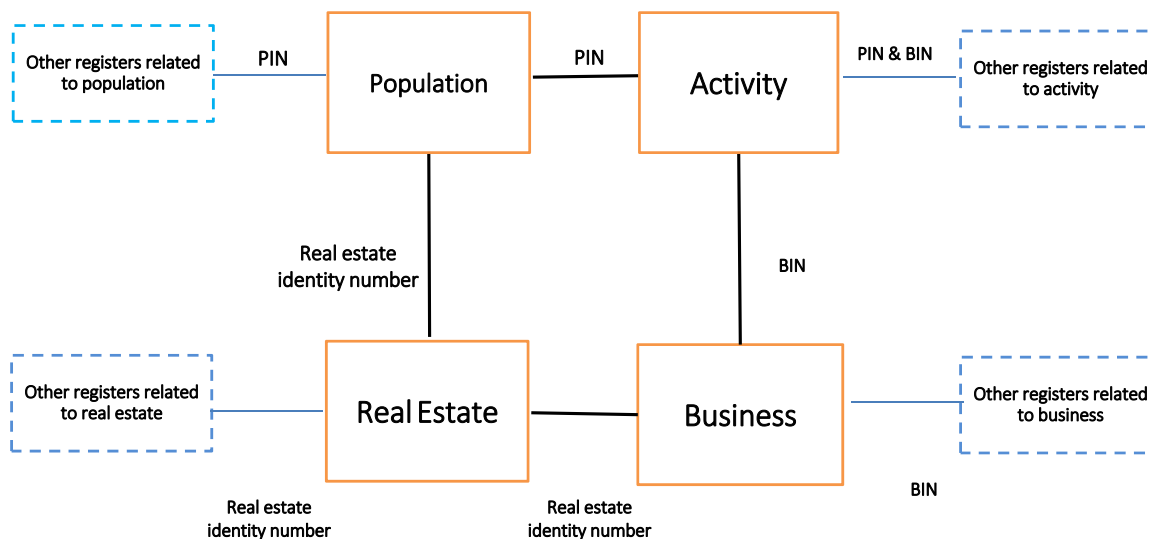

SBR in IRAN

- High Council of Statistics has presented 7 Orders About IRANSTARS about 1 year ago
- According to IRANSTARS project, one of main registers is Business Register
- Office of Cultural, Trade and Services statistics is responsible for SBR
- The unique code of this register is BUC(Business Unique Code)
 - The plan of creating BUC is confirmed in High Council of Statistics two months ago and SCI is responsible for implementing it.
- BR's foreign keys for linking to other registers are:
 - BUC
 - PIN
 - Postal Code
- The primary key is BUC

SBR in IRAN: contents

The content of Iran's SBR are:

- Name of business
- Postal code of business place
- Business Unique Code(BUC)
- Main activity
- ISIC code of main activity
- Tenure status(Personal- Enterprise)
 - PIN of Owner
 - BUC of Enterprise
- Activity status (Active- Inactive)
- Telephone Number

SBR in IRAN: contents(Continue)

- Name of permit's owner
 - PIN of owner
 - BUC of enterprise
- Type of business (Enterprise/Establishment)
 - Enterprise office address
 - Enterprise office telephone
- Number of employees
- Type of permit
- Number of permit
- Date of permit
- Expiry date of permit

SBR in IRAN: Related Organizations

• Tax organization(Base Register)

- State organization for registration of Deeds and Properties
- Ministry of Industry, Mining and Trade
- Post Organization
- Islamic republic of Iran Customs Administration
- Police department(Cars Database)

SBR in IRAN: Related Organizations

- Ministry of Science, Research and Technology
- Ministry of Health
- Insurance (All Insurance Companies)
- Ministry of Agriculture
- Ministry of Cooperative, Labor and Social welfare

Our Challenges

- Having many reference of permits issues
- Difference between legal units definitions
- Challenge in tracing birth, death and change of business
- Lack of business unique code (BUC)
- Lack of using postal code in business permits
- Identifying business with more than one permit
- Identifying places with more than one business

Our Challenges

- Identifying difference between business, enterprise, establishment
- Identifying businesses with more than one place
- Unclear and parallel rules for issuing permits
- Different organizations for giving permits
- Unstructured Total Information Systems

Our Activities

- Providing plan of Business Unique Code
- Identifying numerous references of permits
- Determining Tax organization as base register of SBR
- Determining clear and specific definition of business
- Determining primary key and foreign keys of SBR
 - BUC
 - POSTAL CODE
 - PIN
- Getting raw data from organization databases and their assessment

Our Activities

- Now we are implementing SBR
- We are planning to fill our SBR fields with other registers based on linking with other registers
- Post company passed a rule to make postal address as an official address
- In the postal code we have a logic structure to identify locations
- With postal code and trying to implement GNAF , our addresses will be based on location

Our Problems

- Information confidentiality (TAX organization and some other)
- Unsuitable collaboration from organizations
- We have many codes on business permits which are not compatible with each other
- Lack of full coverage of information units into organizations databases(Registers) and having missing data
- Lack of enough powerful rules to encourage/force organizations to collaboration

Our Problems

- Having illegal establishments
- Having weak Tax system in IRAN
- Lack of BUC
- Lack of linkage between Information Systems in our country between organizations
